

**SECOND AMENDED ORDER ON DEFENDANT'S MOTION FOR
COMPETENCY/MENTAL HEALTH EXAMINATION**

On October 30, 2023, the Defendant was charged with Count I: Attempted Murder, a Level 1 Felony and Count II: Aggravated Battery, a Level 3 Felony.

On November 8, 2023, the Defendant was charged with Count I: Murder and Count II: Aggravated Battery, a Level 3 Felony.

On November 1, 2023, an Initial Hearing was held in F1-9853 and Attorney Mark Chargualaf was appointed as Public Defender. Bond was set in the amount of \$500,000.00 Cash plus \$500,000.00 Surety. An Omnibus Hearing was set for January 19, 2024 @ 10:00 am; FPT for March 8, 2024 @ 10:00 am and a Jury Trial on April 8, 2024 @ 1:00 pm.

On November 7, 2023, Attorney Mark Chargualaf filed with the Court a Motion for Competency and Mental Health Evaluations to be conducted on the Defendant.

On November 8, 2023, an Initial Hearing was held in MR-10150 and Attorney Mark Charguaalf was appointed as Public Defender. Defendant was ordered held without bond. An Omnibus Hearing was set for January 19, 2024 @ 10:00 am; FPT for March 8, 2024 @ 10:00 am and a Jury Trial on April 8, 2024 @ 1:00 pm.

The Court does now appoint two mental health professionals to perform a Psychiatric

Examination of the Defendant to determine the Defendant's mental health status and his competency to stand trial and to assist his attorney in preparation of his defense in this cause.

The Court now appoints John M. Spores, PhD, JD and Rebecca Mueller, MD, as examiners to determine whether the defendant is competent to stand trial and aid his attorney in presenting his case as required under IC 35-36-3-1. Defendant is currently confined in the Porter County Jail. An Omnibus Hearing is set January 19, 2024 @ 10:00 am.

IT IS, THEREFORE, CONSIDERED, ORDERED, ADJUDGED AND DECREED by the Court that the following medical professionals are appointed to examine Defendant for the above purpose:


